We are pleased to announce that we will be updating 103 this year to our "Seascape" theme. Although we are seeing a rise in construction costs and unpredictable delays in furniture, appliances, and construction material we are working with our vendors to ensure that we will be able to complete this unit without major delays. With the completion of this unit, we will have completed our unit update in all of the Palmetto Beach Club units.

Just as Palmetto Beach Club strives to continue to improve the inside of our units, Regency Towers is tasked with keeping the common areas of our resort up to date and in well working order. In order to meet this goal, Regency Towers is repairing the exterior corridor floors and ceilings. They completed several of the floors this fall and winter and will continue this project this upcoming fall and winter. This project is very labor intensive and does require the entire floor to be shut down for at least a week per floor. At this time we are unsure of the maintenance schedule, however we are working with the management staff at Regency Towers to ensure as little vacation disruption to our owners as possible. If your floor will be undergoing maintenance during your stay, our management team will be contacting you directly.

You will notice an increase in your 2021-2022 maintenance fees. This increase is due in part to the items I previously mentioned but also to rising vendor costs and regime fee increases from Regency Towers. None of us like for these increases to happen, however they are necessary in order to continue for our guest and owners to enjoy the comforts of our units and resort. Your board strives to keep our maintenance fees low without sacrificing services.
